Hi Katie

As discussed I'm working on a piece for Sunday following information released to me from the Haemophilia Society. I'll outline a bit of background first then my specific inquiry...

BACKGROUND:

Following the publication in February of the Self-sufficiency in blood products in England and Wales: A chronology from 1973 to 1991, the Haemophilia Society lodged an FOI request asking for access to the documents referred to in the report.

They received some (I think in July). Having looked over them, the Society is claiming that information in the documents contradict some of the report's key conclusions.

In particular, the report concluded that no-one acted wrongly in light of the facts that were available to them at the time. It also stated that the prevailing opinion in the 1970s and the early 80s was that NANBH (now known

as Hep C) was a mild infection and often asymptomatic.

However, they have a letter dated 15 September 1980 from D Walford, DHSS to Mr Harley (reference 99), it states that NANBH can be rapidly fatal.

The documents also show that in 1984 (reference 133, meeting of the Haemophilia reference centre directors, 10 December 1984) no clear instructions were given as to whether to inform people of their HIV status after they were discovered to be HIV positive following treatment with contaminated products. Instead, results were given only if people asked or at the discretion of doctors. According to the Haemophilia Society, the government said people were informed of the status as soon as it became known someone was HIV positive.

My questions are essentially a response to those allegations:

Basically, the Haemophilia Socieity is saying that the government withheld information from people who were HIV positive. Did they?

And that the DoH knew the risks of NANBH but downplayed them? Did they?

The Haemophilia Society says this re-opens the case for a public inquiry. Is that likely to be considered?
