I have now had the chance to read David's supplementary report on Professor Ludlam, which was sent to you on 4 November.

I agree with his conclusion that there is no evidence to support these allegations. Even though there is nothing new in these allegations, David's suggestion that the medical records are examined in detail in order to draw a line under this would appear to be sensible. I would hope that this could be done fairly quickly, so that we can intimate our decision to the Penrose Inquiry as soon as possible.

In the meantime, I agree that we should provide reassurance to the Penrose Inquiry that we (and the Police) have no concerns about them approaching witnesses. The only difficulty that may arise is if some members of the medical profession refuse to provide statements on this matter until the issue of criminal proceedings is resolved. The Penrose team have previously told us that certain witnesses may have been previously 'advised' in these terms by the police. We'll have to wait and see on that.

I suggest we agree with David's recommendations (subject to the further investigation being conducted as quickly as possible) and ask to see a copy of his letter to the Penrose Inquiry before it issues.
