Mrs. M. Benn,

Thank you for forwarding the letter of 22 November from Miss G E Buckley about Britain's drive towards self-sufficiency in blood products.

This country has been self-sufficient in whole blood for a number of years now. In 1982, the Government decided that we should achieve self-sufficiency in blood products also, and commissioned the re-building of the Blood Products Laboratory (BPL) at Elstree. In order to get this new factory operating as soon as possible, we have adopted a fast-track design and build method of project management which is the first of its type in the NHS. Construction is on schedule for completion by its original target date of January 1986. There has been no delay in the project through any reduction in financing. The new factory will have the manufacturing capacity to provide the blood product needs of England and Wales.

Self-sufficiency does depend on Regional Health Authority giving priority to the procurement of the substantial amount of additional plasma that BPL will need from National Blood Transfusion Service donors. Regions have been reminded of the need to ensure they meet the plasma procurement targets the Department set for them in 1981. Discussions are continuing with the few Regions where such action has not yet been taken.

We are acutely aware of the anxiety Miss Buckley's relative and all haemophiliacs must suffer and I recently met representatives of the Haemophilia Society to explain to them the steps the Government was taking to deal with this problem. I hope Miss Buckley will be reassured by the actions I have described.

Dear Mr. Benn,

I was surprised & shocked to read in the Guardian on Tuesday that a £21 million plan to make Britain self-sufficient in blood products has been delayed by the Government Health Cuts. I quoted Mr. John Patten stating that Britain would not be self-sufficient until late 1986.

A Transfusion specialist advised that Britain would not be self-sufficient even then, unless Health Ministers were prepared to spend an extra £1 million a year to produce the raw material blood plasma, but ministers have no plan to do so. This is both disappointing & distressing.

I wrote to Eric Varley several

years ago about this matter & I sent
the the minister's reply, which stated
that Britain hoped to be self sufficient
by 1984. (at least)

When one has experienced having an
haemophilic - the family you
realise that factor 8 is a life line
to the sufferer.

My niece's eldest boy (14 years of age)
is a Haemophilic, who needs
injections of factor 8 almost every
week, & when he has a bad bleed
has to spend time in hospital &
have several injections.

You can imagine our anxiety
at the thought that the injections
may contain the "Aids" virus, &
could mean death.

Stephie listens to the news &
reads the papers about 'Aids' & becomes
very distressed.

May I appeal for your help in
the matter. To make Britain
self-sufficient, without having to import
blood from America is vitally
important.
