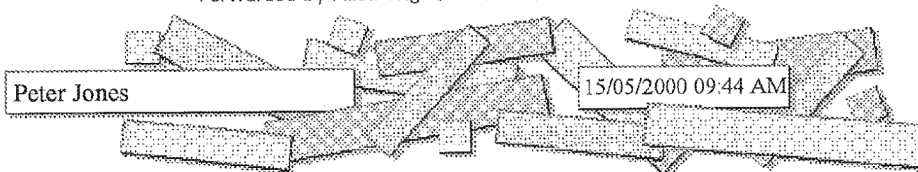
Please see. Now we have chairman sorted out could Clair/Ian please liaise with HSD to develop membership list and talk to Pat's office about possible dates.

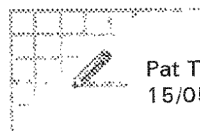

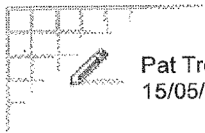
