I am sorry that I have not been back to you before now about inspection. The good news is that it appears we anticipated would be such a process and we have some lever arch files containing the documents you require to see. However, in the eleven years that have passed DH has moved about somewhat and I need to ensure that we disclose the relevant documents. We discussed an end date and I wonder if your suggestion could be extended to Friday 4th February 2000.
