## **HCV Look Back: Estimate of Costs**

As promised at the last meeting of the Ad Hoc Advisory Committee I am now enclosing the estimated total costs of this exercise that are likely to be incurred by the NBA, based on our experience to date.

The administration costs have been broken down on a Zonal basis, however, it is still early days to fully establish the increased clinical/administrative/medical sessional time that will need to be devoted to this programme.

Again, the estimated total costs for HCV testing needs to be viewed with caution as I am only now just beginning to receive the LBF3 forms with the test results. So far considerably more than 5% of the samples are having to be submitted for HCV PCR testing but this may well balance out as the total number of identified recipients looks like being less that the originally estimated 3,000.

Barry Savery is introducing a mechanism for quarterly monitoring which will include central monitoring of the LBF3 forms. The LBF3 forms will be used as a mechanism for central invoicing and a quarterly payment system for the HCV testing laboratories.

I would like to suggest that the NBA institutes a quarterly billing arrangement with the Department of Health for the laboratory and administrative costs of the HCV Look Back programme such that the NBA can organise central payment from the NBA to the laboratories and the NBA zones concerned.

I hope that this will prove satisfactory and would appreciate your guidance on how to set this central billing mechanism in place as soon as possible as the NBA has already incurred a considerable amount of increased expenditure.

I also have no doubt that the PHLS labs will soon start getting restive if the NBA doesn't start reimbursing them for the HCV testing already undertaken. So far I have received approximately 50 returned LBF3 forms with testing and counselling completed but these are now coming in at an increasingly higher daily rate and would be helpful to get central DoH billing and NBA payment mechanism in place as soon as possible.
