I am very sorry for the delay in providing this response. As I said before I thought that this had already been dealt with by Charles Lister earlier this year. As he is no longer available I have had to go through the earlier emails with his brief notes. It is clear that he had decided that a "general" response to the points raised by Ms Grayson would be the only way forward.

Ms Grayson is a very active **GRO-D** organiser of Haemophilia Action UK, the main aim of the group is to secure a public inquiry into contaminated blood products, the group is already taking legal action against companies in the US who supplied plasma products in the 1970s. The second aim is to get the Government to pay full compensation to all haemophiliacs infected with hepatitis C through blood products. The announcement made by John Reid on Sat 30 August that an ex-gratia payment scheme is to be set up, has not appeared her and we can look forward to a great deal more correspondence and PQs from her MP Jim Cousins.

The response I have given is very short and general, better to say less than more, this was apparently what Charles had agreed to do. It is not clear whether you needed a draft letter or just a response form us. I have provided the latter.

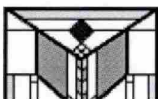

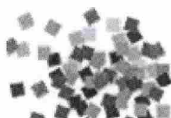
