I provide this statement in response to a request under Rule 9 of the Inquiry Rules 2006 dated 29 October 2018

I, Bernard Birkett, will say as follows: -

### Section 1. Introduction

- 1. My name is Bernard Birkett. My date of birth is **GRO-C** 1942 and my address is known to the Inquiry. I am retired, and married with two children, four grandchildren and three great grandchildren.
- 2. I am a haemophiliac with Haemophilia A, and my condition is mild to moderate. I intend to speak about my infection of Hepatitis C as a result of being treated with Factor VIII products. In particular, I intend to speak about the nature of my illness, how the illness affected me, the treatment I received and the impact it had on me and my family.

# Section 2. How Infected

- In May/June 1976, I was treated at the Sheffield Royal Infirmary for a dental extraction. The doctor in charge was Prof Blackburn. At this time, I was infected with Hepatitis C after being given contaminated Factor VIII products.
- 4. I returned to my employment some time after being discharged from the Haemophilia Centre. Following that, I did not attend the Haemophilia Centre for several years.
- 5. In the early 1980s, I received appointments to attend the Royal Hallamshire Haemophilia Centre. After several visits, I asked why I was being screened. It was only then that I was told that I had been infected with Hepatitis C as a result of infected blood products.
- 6. Following that visit, I was seen on a very regular basis.
- 7. I was advised that I was suffering from clinical hepatitis. I was told that there was no treatment available, and that it was only a matter of time before I would get better. The only advice I was given to manage my condition was to avoid fatty foods and too much alcohol. The doctor I saw at that time was Dr GRO-D.
- 8. It was not until the 1990s, after having a liver biopsy, that I was advised about the effects of alcohol by Dr Makris. I should have been given this information twenty years earlier.
- 9. I now know that I am suffering with cirrhosis of the liver, as a result of being infected by contaminated blood products.
- 10.1 was not given any information of others being infected.

### Section 3. Consent

11. I do not believe that I was treated or tested without my knowledge.

## Section 4. Impact

12. The mental effect of being infected with Hepatitis C and knowing that it would lead to cirrhosis of the liver is soul destroying. Now, being monitored for liver cancer greatly adds to that stress.

#### Section 5. Financial Assistance

- 13. I have received financial assistance from the Skipton Fund and the NHS Business Services Authority.
- 14.I was informed about financial support by the Sheffield Haemophilia Centre and the Skipton Fund.
- 15.1 received two lump sum payments, and I am receiving a monthly payment.
- 16. The process of applying for financial assistance was to inform the relevant fund of my medical situation. They then sent a claims form to be filled in by the medical team that was caring for me.
- 17. There have been no difficulties obtaining assistance and to my knowledge, no preconditions have been imposed.

### Section 6. Anonymity

18. I do not wish to apply for anonymity as I would like people to know how a group of unfortunate people have been mistreated for so long by successive governments.
