	believe that my outlook was exacerbated by the lack of publicly available
	information about the nature of the disease and the availability and potential
	success rate of early medicines. I recall the film 'Philadelphia' was released in
	early 1994, and that there were some obvious parallels given the subject of HIV
	and the impact on the central character. I still recall vividly how emotional I felt
	as I watched it. I rang home immediately after watching the film, just to say
	hello.

13.	In GRO-B the family home was moved from London. A key	factor in the decision
	to move was the difficulties GRO-B faced GRO-B	and after gro-вwas
	made redundant by them, in gaining new employment.	This was as a direct

logistical difficulties when GRO-B died just five years later. My worry about GRO-B being isolated from GRO-B family was heightened because GRO-B was so unwell. The longer commute and distance to see GRO-B caused me great concern. Above all, it was very difficult and extremely unpleasant to see someone I love suffering and changing as result of the treatment that GRO-B had to have to try to clear the virus. I remember very well the side effects; both physical and mental, of the medicine, and certain memories of this time will always stay with me.

- GRO-Bis a strong, proud and independent person and has been incredibly brave 14. to undertake the several courses of treatment and to fight the virus. I am immensely proud of GRO-B After three courses of failed treatment, I remember talking GRO-B and encouraging GRO-B to apply for a new trial of treatment that GRO-B had the opportunity to partake in. I wanted GRO-B to try one more time to beat the infection. I wanted GRO-B both to clear the infection; particularly because of the other health issues GRO-B was suffering from that I suspected were linked, and of course to increase GRO-B chances of living longer. I know it was a horrible choice for GRO-B to have to make and knowing GRO-B would also have to undergo those subsequent treatments without the support of someone being in the GRO-B made the situation even harder GRO-B and same house after caused me much anxiety particularly at my inability to be more practically I recall having to get to the hospital quickly on a couple of supportive. admitted suddenly. Seeing the impact of those occasions GRO-B courses of treatment on GRO-B , even from my sheltered space and from a distance at times, was very tough.
- 15. The side effects of the different medicines were not fully understood at the time that they were administered GRO-B and I believe they are not well understood even now, but it seems to me that they have manifested over the years in ways that have been upsetting. I explain this further in the paragraph below. The side effects have given me regular concern GRO-B health and indeed perhaps even more frustratingly have directly impacted our relationship GRO-is

a very active, highly capable and fiercely intelligent person, but whilst seeks to hide or dismiss seeks to hide or dismiss malaise, I continue to worry about health. The long-term conditions that GRO-B has and GRO-B susceptibility to further illness cannot; I believe, be considered as simply age-related.

16. Whilst incredibly proud of GRO-B including GRO-B determination to both fight the disease and remain fully active, the heightened sense of anxiety and occasional mental 'fog' which I believe the medicines have directly caused, have created misunderstandings or difficult periods in our relationship from time to time. GRO-B has a heightened fear that things may be wrong or could go wrong, particularly with young children GRO-B has been incredibly supportive of our family and GRO-B grandchildren but this anxiety for both their and our safety has caused arguments, made it harder to relax on occasion at family gatherings, and indeed made certain topics more difficult to discuss lest it worry GRO-B unduly. It is only recently that this has been identified as a likely side-effect of the medicine; making it easier to understand, but the impact cannot be under-estimated. It cannot be easy for GRO-B also given the incredible support
