There was also considerable review of our progress to date (you have the latest numbers, so do the Society trustees) and of the spontaneous clearance issue.

On that I note your comments about last Thursday. We now have about 80 applications on hold because the answers to 2A ii and iii are both "no". Unless Christine Lee says to Elizabeth Boyd, who is one of our directors, that she can approve such cases for whom the anser to 2 A iv is "yes", we shall presumably have to fail the lot.

That leads me to the appelas process, the need for which is now critical. We have so far rejected 5 applications:

one appeared not to have had any NHS treatment

- 3 show infection well outside the qualifying period (thank you for your

suggestion of the 35-day period of grace)

- a consultant was unable in one case to isolate the source of infection because of a period of IVDA preceding the hospital treatment.

We have had a letter from that last applicant asking what the appeal process

is; there are a few similar cases where we are awaiting the consultant's opinion on the IVDA, which might similarly lead to appeals.

At the very least we need to have something to say about what the process will be and when people will be able to instigate an appeal. This is especially important in view of the number of Scottish applications coming through lawyers, notably Ross Hardie.

I note with pleasure the imminent arrival of new directors. London residents would be highly appreciated, since they can share the not inconsiderable burden of approving applications; those who live further afield will, I am sure, have their uses.

I look forward to seeing you in Alliance House soon. Incidentally, we will be getting the printed Stage 2 documents next week - with luck we will be able to show you some copies fresh off the press.
