Thank you for your submission regarding the recent publication of Lord Archer's Independent Inquiry Report. MS(PH) has seen this report and is very concerned about the contamination of NHS blood and blood products during the 1970s and 1980s. She is particularly concerned about how this issue has been handled.

The Minister feels that it is clearly not acceptable in such tragic and unique circumstance for DH to claim no liability and to give no more money to the Trusts.

She has asked for the following work to be done by 9am tomorrow morning. She has also asked for a list of the Ministers responsible for blood policy since 1970. I have contacted the Cabinet Office regarding this and they will be responding this afternoon.

Copies of all documents withheld from the inquiry.

Brief Chronology of patients being infected through NHS blood and blood

products - in terms of when they have been identified as having been infected and, if known, when they are likely to have been infected. Details of any payments made directly to patients who received contaminated blood and blood products - in relation to the two additional payments made in the early 1990s - one in 1990 and one in settlement of litigation in 1991.

Background on the setting up of all three trusts - MacFarlane, Eileen and Skipton specifically:

- how each was set up?
- why each was set up?
- how the amounts of funding were decided?
- 5. A brief note on the attitude of the Government of the Day to this issue.
