Repeated 29 July, 1986 - +ve to HTLV-III by ELISA. Wellcozyme K59640.
Confirmed by in-house immunofluorescence test.
Very recent sample also +ve, but report not back yet.

Tested first with Wellcozyme and confirmed using Organon Kits.

Colindale have been asked to do a Western Blot and samples have been sent.

As far as mother remembers, he was last treated end of January.

Never had a blood transfusion, or blood products (except Cryo and Factor VIII). No other risk factors for AIDS.

Clinically well. No abnormal findings.

Patient No. 2

Age - 15 Years and 4 months. Sexually mature, but believed not active. Severe haemophilia. Not in any risk category.

1978 - All NHS Concentrate.

Records start in 1978. Prior to 1984 - Cryo.

1979 - treated mainly with Armour, some NHS concentrate.

1980 - 1983 - mixture of Armour and NHS. Multiple treatments.
3 - 4 per month.

1984 - Exclusively NHS - Non-Heat Treated. Remained on NHS non-Heat Treated until 18 June, 1985. Product issued for home treatment as follows:

HIV test schedule not well documented.

Tested April 1985 - Negative.

5 July 1985 - Antigen & Core Ab. No virus, no Ab. Tested using GP41 and P24. (Recombinant DNA probes for virus + Antibody).

April, 1986 - Positive by ELISA and immunofluorescence.

Dr Hill is checking samples to see if he has any samples to fill in between these dates.

No blood products other than cryo and Factor VIII.

No lymphadenopathy. Clinically well.

Has sufficient product issued for home treatment to cover holidays, etc. so that they do not change what they are using. Use home treatment card while they are away and ask Centre to write to Dr Hill.

3 boys who had Y83006C still sero-negative. One also had A24704.

Dr Hill was asked why he thought the boys had not sero-converted earlier. Although both boys were multiply treated, Number 2 was treated with NHS only during the period of maximum risk. Number 1 - just lucky as he had only moderate amount of treatment?

Dr Hill thinks that Number 1 is probably product-related and Number 2 possibly, but evidence is not so good.
