FOLLOWING DISCUSSIONS WITH NEXT ASHWORTH DURING HIS LAST UK VISIT OVER BRITISH PRESS REPORTS ON AIDS, I WAS PLEASED TO RECEIVE YOUR TELEX JANUARY 26 DETAILING A CUTTER POLICY STATEMENT SHOULD QUESTIONS ARISE FROM DHSS.

FURTHER COMMENT IN THE LANCET ISSUES JAN 22 PAGES 162-164 AND JAN 29 PAGES 213-214 HAVE PROMOTED FURTHER CONCERN IN THE UK.

DR. PETER KERNOFF CO/DIRECTOR OF THE ROYAL FREE HOSPITAL HAEMOPHILIA CENTRE CONTACTED BARRY BARBER FEB 1ST TO REQUEST SOMETHING IN WRITING FROM CUTTER I.E., WHAT ARE CUTTER DOING ABOUT AIDS ? DO WE ACCEPT HOMOSEXUAL DONORS ? WHERE ARE OUR PLASMA CENTRES SITUATED ? HOW MUCH PLASMA FROM SAN FRANCISCO OR NEW YORK AREAS WOULD HE PROCESS ? THESE QUESTIONS RELATE DIRECTLY TO RECENT PUBLICITY.

THE ROYAL FREE ACCOUNT WILL UTILIZE APPROX 5 MILLION UNITS COMMERCIAL FYIII THIS YEAR AND CUTTER HAVE BEEN AWARDED HALF THE BUSINESS - SUPPLY TO COMMENCE APRIL. DR KERNOFF WOULD BE COUNTED AMONGST THE TOP SIX IN THE UK HAEMOPHILIA TREATMENT.

I AM WELL ABLE TO BUILD A LETTER AROUND THE FACTS STATED IN THE PROPOSED POLICY LETTER. HOWEVER, IN A COUNTRY WHICH ADVOCATES A VOLUNTARY DONOR SYSTEM, I BELIEVE THE CUTTER PROPOSAL TO CONFRONT REHUNERATED DONORS WITH THE STATEMENT OUTLINED IN THE TELEX WILL BE THOUGHT OF AS A 'FATHER TIME' APPROACH.

THE PRESENT SITUATION ALSO AFFORDS THE TWO UK FRACTIONATORS MR JOHN HATT SCOTLAND AND DR R LANE AT ELSTREE FURTHER AMMUNITION TO PRESSURE GOVERNMENT FOR THEIR GOAL OF UK SELF SUFFICIENCY IN PLASMA PRODUCTS.

SHOULD A COMPANY RESPONSE FROM THE HIGHEST LEVEL BE CONSIDERED FOR PUBLICATION IN A JOURNAL SUCH AS THE LANCET ? IT WOULD AT LEAST PUBLICISE THE COMPANY AS BEING ACTIVELY INVOLVED IN THE RESOLUTION OF THE AIDS PROBLEM.

THANK YOU FOR SENDING THE INQUIRY OF DR. KERNOFF. WE SUGGEST THAT, IN ADDITION TO THE CUTTER STATEMENT OF POLICY IN THE TELEX OF JANUARY 29, YOU ADD THE FOLLOWING INFORMATION REWORDED AS NEEDED TO FIT YOUR RESPONSE:

THE FIRST TWO QUESTIONS ABOUT OUR POLICY ON ACCEPTANCE OF DONORS IS COVERED BY OUR STATEMENT. THE PROGRAM BEING INSTITUTED IN ALL CUTTER-OWNED AND CONTRACT CENTERS WILL PROVIDE ALL PROSPECTIVE DONORS WITH INFORMATION ON A.I.D.S. AND, IN PARTICULAR ON THE APPARENT BLOOD-RELATED ASPECTS OF A.I.D.S. BEFORE ANY DONATION CAN BE ACCEPTED, THE DONOR IS REQUIRED TO CERTIFY IN WRITING THAT HE OR SHE IS NOT A MEMBER OF THE SPECIFIED HIGH RISK GROUPS, I.E. HOMOSEXUAL, USER OF INTRAVENOUS DRUGS OR A RECENT RESIDENT OR VISITOR TO HAITI.

CUTTER HAS NO CUTTER-OWNED OR CONTRACT CENTERS IN THE CITIES OF NEW YORK, LOS ANGELES OR SAN FRANCISCO. THE CENTERS FROM WHICH WE SECURE PLASMA TEND TO BE GEOGRAPHICALLY DISPERSED THROUGHOUT THE U.S. WITH RESPECT TO AN OBSERVATION THAT OUR APPROACH COULD BE CONSIDERED AS RATHER TRADITIONAL, IT SHOULD BE NOTED THAT THE A.I.D.S. SITUATION IS A TERRIBLY COMPLEX MIXTURE OF MEDICAL AND SCIENTIFIC MYSTERIES AND, AT THIS POINT, WITH SUBSTANTIAL SOCIAL undertones. THERE ARE NO ANSWERS TO MANY IMPORTANT QUESTIONS. YOU CAN BE ASSURED THAT CUTTER IS FOLLOWING ALL DEVELOPMENTS WITH GREAT CARE AND WE ARE IN VIRTUALLY CONSTANT COMMUNICATION WITH RESPONSIBLE HEALTH AUTHORITIES ESPECIALLY AS IT CONCERNs OUR SEGMENT OF THE OVERALL A.I.D.S. PROBLEM.

WE WILL BE RESPONSIVE IN OUR DONOR ACCEPTANCE CRITERIA TO SCIENTIFIC AND MEDICAL DEVELOPMENTS AS AND WHEN THEY OCCUR TOGETHER WITH ANY REQUESTS OR REQUIREMENTS OF REGULATORY AGENCIES.
