We keep certificates of destruction on a working file at DRO Nelson, but I doubt there would be any useful purpose served by anyone having sight of them, as they only states that an amount (in weight), has been collected from us on a particular date and received by the recyclers and destroyed. As I said previously it forms part of the audit trail, but does not give any specific details of individual files that have been destroyed.

Roseanne - what would the availability of this certificate of destruction be (relevant contribution is as follows)?

Mr GRO-A refers to the destruction of papers dating back to the 1970's and 1980's, relating to haemophilia treatment and blood safety. My officials have established that, during the HIV litigation in the 1990's many papers from that period were recalled for the purpose of the litigation. We understand that papers were not adequately archived and were subsequently destroyed in error in the early 1990's. Officials have also established that a number of files were marked for destruction in the 1990's. We understand that a decision, most probably made by an inexperienced member of staff, was responsible for the destruction of a number of files.
