Steve,

I would be grateful for your advice/comments on two PQs that we have received about the destruction of papers.

Given that this has become an issue, I think it would be helpful if we could try to draw up a list of files on blood safety that we do hold by subject area ie. committees, finance, briefings, PQs, imported plasma, etc... going back to to the 1970's and 1980's. It makes us vulnerable to say that we are aware of papers that have been destroyed, without having a clear understanding of what we do hold.

When we met last week I mentioned that we are not resourced to undertake detailed enquiries about past papers. I wondered whether you would be able to identify someone to help out so that we could establish what files exist. Grateful for your views on this approach. At present its difficult to assess if this issue will quieten down.
