Subject Action points from SofS meeting with MS(PH) and Baroness Thornton 10 Sept - Contaminated Blood

Debby, colleagues

As you are aware, SofS met with MS(PH) and Baroness Thornton yesterday to take stock on where we are on contaminated blood. A number of issues were raised including the following:

- SofS wanted to invite Paul Goggins to explain his proposals eg about access to NHS services for those affected - to see if there was anything the NHS could do better. Action point - SofS will need a draft letter to send to Paul Goggins - could a draft be sent to Matt Baird by 2pm Thursday, 17 September?

- Ministers were keen for some work to be done on the smaller points we can address such as working with DWP on the benefits forms. Baroness Thornton has already written to DWP about this so there was a suggestion that we could announce a joint meeting with them on this issue, or announcing the outcome of work with them to resolve issues around the form etc. Action points - liaise with Baroness Thornton's office and follow up the letter. To feed back to Ministers by end of the month.

- Possible links to the announcement of the outcome of the prescription charges review. Action points - please confirm when the outcome of the review is scheduled for and whether this a good news announcement?

- Generally, speaking Ministers wanted the Department to be more on the front foot and take credit for the things the Government had done in this area (eg the setting up of the Skipton Fund in the first place). They wanted better handling plans, putting out positive messages/finding good new stories to announce on this issue, rather than being passive and defensive. Action point - A note should come up to Ministers - for MS(PH) to comment on before going to SofS - setting out some sort of short to medium term communications plan (by end of the month).
