There are possibly 4 elements to the Sunday Herald article (http://www.sundayherald.com/40878);

- That the waiver statement is 'morally outrageous' [quotes from David Davidson and Shona Robinson]
- That it is revealed in a 'leaked documents' (and implicitly was being kept out of sight)
- That the waiver 'closes up any more civil claims' [Frank McGuire quote]
- That the waiver 'would stop the facts being heard' [Philip Dolan quote]

Commentary

- 1. My submission of 11 December proposed that a scheme condition would be "People who receive payments under the scheme would undertake not to institute future legal proceedings against the NHS or Ministers in relation to the situation that formed the basis of those payments." This condition was agreed with OSSE (who advised that such conditions were standard when making ex gratia payments). I understand DoH received similar advice from their lawyers.
- 2. The condition was further amplified in the Q&A issued at the time of the announcement by the four UK health Ministers on 23 January. The wording used was "People who receive payments under the scheme will be asked to sign an undertaking not to institute proceedings against the NHS or Ministers in relation to their having been infected with Hepatitis C from blood, blood products or tissue received from the

NHS before September 1991" and it is this wording that is quoted in the Sunday Herald article. However, it was not included in the press release itself.

- 3. We provided the abovementioned Q&A to Philip Dolan and to the Hepatitis C Resource Centre at the time of the January announcement.
- 4. Civil claims under CPA are already absolutely time barred. Civil claims for negligence are also likely to be already time barred (since actions have to be raised within 3 years of the person becoming aware of the basis for a claim) – but in this case it is within the power of a judge to ignore this if the circumstances warrant it.
- It is very hard to see how an individual signing the waiver would have any effect at all on the facts being heard (eg if there was ever to be a public inquiry)
