The Scottish Government has asked NHS National Services Scotland (NSS) to set up and administer the new Scottish Infected Blood Support scheme - the scheme will act as the single scheme providing targeted support from 1 April 2017 for those in Scotland who are infected with Hepatitis C and/or HIV and their immediate family members. This means that anyone who is a Scottish beneficiary will receive support from that single scheme in future, rather than the current five UK schemes. You are registered as a Scottish beneficiary so you will be eligible for support under the new scheme. Once your data has been transferred, NSS will write to you to provide further information on the support you can access, the team who will be managing and administering the scheme for you and how to contact them. In the meantime, if you have any queries you can contact NSS at NSS.SIBSS@nhs.net. More details on the new scheme are available on the NSS website at nhsnss.org (a link to the scheme webpage is at the bottom of the homepage) and this information will be updated as we approach the launch of the scheme in April.

NSS is an NHS Board accountable to Scottish Ministers. They provide services to, and carry out tasks for, bodies associated with the health service in Scotland. NSS has many years of experience working in health and care. NSS staff have a legal and contractual duty to keep personal information secure, and to handle confidential information safely. In addition, NSS have an individual known as a 'Caldicott Guardian' whose job is to make sure that people's information is handled properly.
