

### Correspondence with Jane Ellison, MP - Parliamentary under Secretary of State for Public Health

I am writing following recent correspondence on my behalf between my MP, Nadhim Zahawi and Jane Ellison, MP.

As you know, I am an HIV infected Primary Beneficiary. I am also the widow of a co-infected haemophiliac who died in 1993. It is three years since Nadhim Zahawi MP, first wrote to the Chair, Roger Evans, asking him to explain the origin and circumstances of the charge on my property, and requesting a meeting to discuss my current situation. The issue remains unresolved.

For the record: The origins of the charge date back to 1990 when an equity charge was placed on our marital home when my husband, Bryan Walton, was dying of AIDS due to NHS contaminated blood. He died at the age of 34 making me a young widow at the age of 31. Both my late husband and I were contaminated with HIV and the Trust had a duty of care for **two** primary beneficiaries, not just one in this marriage.

This period was at the height of fear, stigma and discrimination surrounding AIDS. We had no where to go, no one to help, very few family or friends knew — such was the prevailing climate of fear and isolation. The Macfarlane Trust was the organisation set up specifically for support so we turned to it for help when we had financial difficulties due my husband's decreasing health. We were offered no other option by the Trust but for it to take away the mortgage and invest in our property - it was a case of take it or leave it. I questioned the legality and morality of 'investing' in, and 'profiting' from, the homes of the dying, at the time and since.

As you know, Mr. Evans stated he could not explain the charge as he, nor current staff or trustees were around at the time and he did not have the data. Despite this admission, Mr. Evans refused to arrange a meeting to discuss the charge, and any further attempts by my MP to set up a meeting to find a way forward have been refused. Instead the Trust has responded with statements of 'facts' that are simply not true. Despite repeatedly repudiating the Trust's version of events, providing evidence to the contrary, and several offers to put the facts on the table in a meeting, the Trust has refused to engage in conversation in a face to face meeting - either with staff or members of the board.

Indeed, since my MP became involved, previous arrangements; where the charge was transferred from one property to another, allowing me at least the freedom to move home according to my needs, have been inexplicably stopped -a decision taken at a board meeting in November 2013. It makes no sense. One wonders why trustees would want to constrict the previously accepted freedom and make a situation worse for a bereaved Primary Beneficiary.

A recent attempt by Suzanne Lowe, Talk Mediation, to offer to mediate on the simple matter of transferring the charge from one property to another, was dismissed – shockingly, not directly from the Trust to whom the invitation was sent but via a letter from the Trust's solicitors, Wilsons, who were not party to the offer and should never have been involved.

Sadly, Jan, as CEO, you have not made yourself available to offer assistance, guidance or support on the matter – when I asked to meet you stated you do not have permission from the Board. This also makes no sense.

We have kept the Minister, Jane Ellison MP, informed of the ongoing situation over the years, and in her latest letter to Nadhim, dated 2 March 2016 she recommends;

"Ms. Walton continues her dialogue with the Trust and make clear why she disagrees with the Trust's response."

You have to agree Jan that it is not possible for me or my MP to continue dialogue if the Trustees will not allow a meeting and are refusing to communicate further on the matter - despite the recent offer of mediation.

Jan, will you respect the Minister's advice and arrange a

meeting with me and my MP, Nadhim Zahawi, so a fair, transparent and meaningful dialogue can finally begin?
