Thank you very much for the briefing for the meeting with the Chairman of the vCJD Trust on 2 June.

I was hoping that in addition to this briefing you could draw up a brief note on recent developments relating to recipients of contaminated NHS blood and blood products.

As you are aware, vCJD was found in the spleen of a haemophiliac earlier this year and in the aftermath of the release of the Government's response to Lord Archer's Report there has been talk of how over 800 haemophiliacs are at risk from vCJD. I think it would be very helpful for MS(PH) to have a note about these developments and how it may potentially impact upon the vCJD Trust. Could you please include details of how these developments may influence the Chairman's arguments for his proposals? Have these developments changed the Department's advice at all?

Could you please let me have this note (no more than two A4 sides) **by 11:30am on Monday 1 June?**
