Patrick,

Both documents held under Section 27 (disclosure likely to damage relations between the UK and another state) were subsequently released. I have found both of them in Volume 20 of the Solicitors documents that have been posted on the DH website so I assume this means that they were also released to the Archer inquiry. I have not yet found a reference to say that they were released to Carol Grayson who initiated the review

I attach the notes of the an early meeting of the Project Board which summarises this. The relevant extract says -

'Nineteen documents were withheld when the 'Solicitors' documents were released in November 2006. Carole Grayson requested an internal review of these documents. The outcome of the review is that 18 of the 19 documents were released. The document that remains withheld is an individuals CV. Advice from DCA is that it is very difficult to justify a public interest in withholding any document that is 30 years old, or approaching that date. This will inform our approach to remaining documents.'

Perhaps the reply could go something like this, - I will check with Zubeda tomorrow morning.

Initially 19 documents were withheld when the papers were released in late 2006. Following a challenge by Carol Grayson, there was an internal review, and 18 of the 19 were released. The document not released following the internal review is an individual's CV and is withheld under Section 40 (personal information) of the FOI act. Thus the overwhelming majority of the 600+ papers returned by Blackett, Hart and Pratt Solicitors have been released to the Independent Inquiry .
