SUGGESTED REPLY

A search of Departmental records shows approximately 50 items of correspondence between the Department and the Independent Inquiry into Contaminated Blood and Blood Products.

Only one piece of correspondence dates from before the start of the Inquiry (27 March 2007). This was a letter from Lord Archer to the Secretary of State dated 16 February 2007.

Officials from the Department of Health attended four meetings with the Inquiry. These took place on 25 April 2007, 19 September 2007, 18 February 2008 and 12 June 2008. No meetings were held prior to the start of the inquiry.

The following table shows the main correspondence between the Department and the Inquiry team. The remaining items consisted of emails discussing administrative arrangements relating to meetings and the delivery of documents.

Background

The MP is joint Secretary of the All Party Parliamentary Group on Haemophilia.

Lord Archer of Sandwell set up an independent inquiry in 2007 into the contamination of NHS blood and blood products with hepatitis C and HIV during the 1970s and 1980s. Officials have met Lord Archer's team on a number of occasions and supplied him with a large number of official documents. These documents are now available on the Department's website.

When officials last met Lord Archer in June 2008, he intimated that his report may be published in the autumn of last year. We have had no further information from Lord Archer as to the likely publication date, but there are some indications that it could be later this month. This is one of a number of PQs from Jenny Willott that appear to be anticipating the report.
