Thanks you for copying me into this exchange. There are two points I would like to record:

Firstly, I thought that Sol's previous advice was that, although the position was far from clear-cut, their advice was that we should disclose the document, for the reason which have been circulated many times. I appreciate that having circulated the draft to different lawyers, the advice may have changed but I do not think it is correct to state that those different lawyers "supports the approach we are taking - suggesting that we seek the reasoned opinion of the Attorney General, and that we suggest to the Attorney that the document should be withheld.". That has not been my understanding of the legal advice to date.

Finally, I still feel on balance that minister's decision to release thousands of documents to date, weighs heavily in favour of disclosure of this document.

# Zubeda,

Since we spoke earlier I have spoken to Liz Woodeson about this matter and she asked that a senior lawyer here consider it. I have since then referred to Howard Roberts who previously led on FOI matters. Howard proposes that we suggest witholding the information but has suggested that I seek a view from the Director of DH legal services, Frances Logan for her view (in Paula Cohen's absence) to check that she agrees with the approach he proposes. I have asked Frances to respond as soon as possible since Liz would like to send the submission up tomorrow.

The submission will need to be amended in any event to take account of further points that Howard raises about accurately representing Kenneth Clarke's concerns. I will, separately, provide further comments on the submission and draft letter. One of my comments will be that Howard has suggested that regard should be had to the other briefing which was presented to the former Secretary of State, particularly as he recalls that the weight of the briefing differed from that which he received from the CMO. Howard advises that full consideration of the context of the CMO advice is appropriate and that the submission should address the former Secretary of State's concerns in this regard. He does not consider that it could be in the public interest simply to release information which shows that CMO advice was not followed, particularly in circumstances where a former Secretary of State recalls a context

which makes rejection of the advice reasonable. In Howard's opinion a full consideration of the alleged context is essential. Would you be able to add to the submission and letter as appropriate?
