I look forward to hearing from you as soon as possible.





I am now on my fifth cabinet minister in nine years, small wonder they are so ill informed and indifferent.




Time is of the essence as the enquiry closes in a matter of days.

Answer to Norman Lamb, one month later. Enclosed.


To deal with Primarolo's letter to Norman Lamb and kindly passed on to me for comment, please note the following.

A copy of this letter is enclosed. Only twelve days ago Primarolo is repeating Norman Warner's lies that even he gave up repeating in the Upper House in 2004 after I sent him copies of the material I had obtained from the Dublin solicitors and the Eire Dep.of Health and children.

I am not one of Mr.Lamb's constituents, Primarolo's grasp of English counties appears slight.Norfolk is one county, Suffolk is another.I can only assume that for a non-constituent to receive support from an MP not in search of a vote and not obligated to help would be beyond her comprehension.

I do not recall asking for information, under the Freedom of Information Act, about the Skipton Fund Anyone can obtain information regarding the Skipton Fund by telephoning 02078081160. Nicholas Fish, an administrator of the fund has always been most helpful and informative.

Paragraph 3. defies belief, does Premarolo know nothing of the facts or is she happy to



re-introduce the lies that even Norman Warner gave up repeating in the Lords.

The Eire and the Canadian settlements were made on compassionate grounds not as an outcome of criminal charges based on wrong doing(I have a full copy of the Tribunal of Inquiry into the Infection with HIV and HepatitisC of Persons with Haemophilia and Related Matters', otherwise known and referred to as the 'Lindsay Report'. [Judge Alison Lindsay, 4/9/2].

Primarolo states, in writing that,

'the position in those countries was quite different'.

Would she please explain in what way they were,' quite different'?

I am quite sure the ongoing Independent Public Enquiry under Peter Archer QC.,(The Rt.Hon.Lord Archer of Sandwell) would be glad to hear her evidence.

I would suggest, however, that she read the statements submitted by those concerned in this continuing and overwhelming tragedy knowingly inflicted upon NHS patients.

If the government is so sure that no," wrongful practices were employed in the UK." to quote Dawn Primarolo, why do they refuse a public enquiry?

If the donor screening for HepatitisC was not introduced until 1991 why did the NHS continue to use ,throughout the preceding 20 years,donor collected blood known to be infected with HepatitisC (NonA-NonB) and HIV?

Patients treated with products made from this plasma, known to be infected throughout this time, were not informed of the virus they would be given in those products and were given no choice as to accepting the treatment.

Perhaps Ms.Dawn Primarolo would care to answer these questions.
