Please see attached a letter regarding haemophiliacs that requires a draft reply from MS(D) - i would be grateful for a reply by **noon Tuesday 31 January**. I will also send a hard copy in case it is hard to read.

MS(D) written notes suggests that this letter raises 2 specific allegations that previous briefing would suggest are untrue

1. that some alleged destroyed documents are in fact available
2. that they and other material show that the government in some form knowingly imported blood products from a source (i.e. Arkansas prison system) known to be unreliable in terms of contamination.

MS(D) has also asked for a note on 2 allegations.

MS(D) has also asked when exactly the review is going to be published. I think this date should be in either the letters I commissioned for this Friday or this particular draft reply.
