Further to your response below, the advice we have received from SOL in response to Ministers' suggestions on the option of using powers under the 1977 NHS Act is as follows:

"An alternate course of action to a public inquiry would be to put the relevant documents in the public domain so far as we are willing and can legally do so. This might involve an appropriate person reviewing all the documents which we make available and producing a "commentary" on them. This could be commissioned under the NHS Act 1977 as something incidental to the discharge of the Secretary of State's duty to continue to promote a comprehensive health service designed to secure improvement in the treatment of illness, and the duty to provide medical services and other services required for the treatment of illness; because amongst other things it would be a way of passing information to the public about the treatment of illness. Of course the 1977 Act does not empower the Secretary of State to compel witnesses to give evidence or to produce documents therefore if the reviewer wanted to probe beyond the available documents, this may not be possible, and the reviewer's terms of reference should be drawn accordingly. Further, the more such a review takes on the nature of an inquiry in substance (for example the reviewer taking on a

more investigative role), the less appropriate it is likely to be to rely on the powers under the 1977 Act."

Thank you for the submission and proposed note for MS(PH) and MS(R) to send to SofS.

MS(R) has suggested rather than a Public Inquiry we should use the powers under the 1977 Act for SofS to commission a review of ALL the documents (new ones, old ones and if possible Scottish ones) with a view to producing an independent legal/judicial commentary on them and putting all these into the public arena.

MS(R) thought that a retired Judge/QC could do this with an administrative support team, with the aim to complete within 6 months.

MS(PH) thought this was a sensible way forward.

This option is not mentioned in the note for SofS. Could you please redraft the note to include this option and return it to me as soon as possible for MS(PH) and MS(R)'s further consideration.

Thank you for this submission.

At the meeting MS(PH) and MS(R) asked for a draft note for them to send to SofS which, among other things, discusses the possibility of conducting a Public inquiry.

On the inquiry issue this just says "DH officials have advised an inquiry would be disproportionate and not justified in the circumstances". There is no argument, no pros and cons and no costings. Both MS(R) and MS(PH) will expect to see an argument for this decision and the pros and cons of

having a public inquiry which would presumably include the cost. There is nothing in here about the steps that would have to be taken and nothing about the consultation with the Patient Safety and Investigations Branch that Gerard referred to in his note of 26 May.

Can you please provide a redrafted note for MS(PH) and MS(R)'s consideration, which takes account of the above points as soon as possible and no later than close on Monday 26 June.
