

- 1. The papers which you have sent me raise no FOI issue that can be resolved by legal advice. Of course, if a request is so wide that it cannot be answered within the appropriate limit on costs, our policy colleagues may take that point.
- 2. Without seeing the files, I cannot form a view on whether they contain personal information which is exempt from disclosure under section 40 of the FOI Act. In general terms, section 40 exempts information from disclosure when it is protected by data protection legislation.
- 3. I assume that our clients would be interested in whether we have information in our files which can make up for that which is no longer retained by them. You are no doubt aware that there is a separate high profile PO request which is concerned with the disappearance of some of the policy files on HIV/HCV. It seems to me that the reply to our clients should outline the information which Sol lit hold. In that context it may be appropriate to mention the personal information exemption in section 40 of the FOI Act.
- 4. Happy to discuss the issues. However, I will no be in a position in the foreseeable future to trawl through

individual case files with a view to determining whether individual pieces of information are protected from disclosure by section 40.
