We must tactfully resist issues which might be bilateral, unless as I suspect in this case, the issue and Scotland's decision on the petition to compensate will clearly have UK-wide ramifications?

ICB will be commissioning briefings for JMC(Health) today and so we'll play you in.

<u>Sammy</u>, as the agenda develops in response to the replies from JMC(H) members, we will need to bear in mind whether to advise SofS to consider offering the Devolved Health Ministers, the opportunity to hold separate discussions with other DH Ministers on the same day (and diaries permiting) on particular bilateral or three-way issues. That may help prevent overloading JMC(Health) agenda. Let's wait and see how things go by friday.
