#### Foreword from Health Minister Robin Swann, MLA

### Review of the Northern Ireland Infected Blood Payment Scheme – Survey

When I took up post as Minister of Health in January of this year, the issue of support for those of you who have been impacted by infected blood was an immediate priority for me.

I am fully aware of the impact this has had on your lives and I stated my intention to carry out a three phase review of the Northern Ireland (NI) Infected Blood Payment Scheme.

Phase 1 addressed the immediate difference between the rates paid to Northern Ireland scheme beneficiaries when compared with those in England, who have received significantly higher levels of payment since April 2019.

I announced payments in January and March of this year that meant infected beneficiaries on the NI scheme were no worse off in terms of financial support on the scheme than their counterparts in England for the 2019/20 financial year. In addition, I was pleased to also be able to announce payments for non-infected widows and widower on the NI Scheme.

Following this I was delighted to recently announce a permanent uplift in payments to infected beneficiaries on the NI scheme, which brings rates up to the same level as those paid in England. I am keen to build on this progress as I continue phase 2 of my review, considering other aspects of the scheme.

When I met with groups representing those infected and /or affected by contaminated blood earlier this year, I said that I wanted to include our beneficiaries in the ongoing review. It is important to me that I involve you in this work so that I fully understand your views on what support you need to help you to live as normal a life as possible. I want to give fair and equal consideration to the needs of all of you who have suffered as a result of infected blood, including those who have been bereaved.

In order to involve you in this work, I have attached a survey covering a range of support currently available. I would be very grateful if you would take the time to consider and respond to all of the questions and I invite you to express your views in full and include any additional suggestions you would like to be taken into consideration. You are welcome to attach any supplementary supporting information you feel is relevant to the survey, but I would ask that you restrict this to no more than one side of an A4 page to allow the results of the survey to be analysed promptly. It is also important that you do not include any personal information.

It is vital that I hear your views as this will allow me to take these into consideration when making decisions on the best way forward to ensure that our financial support scheme best meets the needs of our beneficiaries here in Northern Ireland. Please be assured that this survey is completely anonymous and you will be reimbursed for any postage costs.



### England - Special Category Mechanism (SCM)

The following table shows the annual payments in England to the different categories of claimant, including Hep C stage 1 with SCM (highlighted in bold).

In England, beneficiaries may qualify for regular payments, equivalent to those paid at Stage 2, if:

- they are a successful stage 1 applicant;
- they feel the infection, its treatment or associated conditions has a long-term negative impact on their ability to carry out daily activities;
- the infection has worsened, but is not covered by the stage 2 conditions.

They need to confirm they have:

- autoimmune disease which was due to, or worsened by, interferon treatment. This includes:
  - Coombes positive haemolytic anaemia;
  - o idiopathic fibrosing alveolitis of the lung;
  - rheumatoid arthritis;
- sporadic porphyria cutanea tarda (causing photosensitivity with blistering);
- immune thrombocytopenic purpura, if autoimmune with antiplatelet antibodies;
- type 2 or 3 mixed cryoglobulinaemia, if accompanied by:
  - o cerebral vasculitis;
  - o dermal vasculitis;
  - o peripheral neuropathy with neuropathic pain;
- been affected in performing your daily duties due to the infection or the treatment.

Upon receipt of an application under the SCM, the English scheme assesses the application, based on criteria provided by the Department of Health & Social Care (DHSC). If an application passes, the individual will receive the higher annual

payment amount backdated to the date NHS Business Services Authority received the complete application. If an application fails, the individual can appeal or can choose to wait six months (from the date of the original application) to reapply – if their circumstances have changed. If their SCM application is refused, they can reapply after six months if their condition has worsened.

### Scotland - Hepatitis C Tiered Impact System

In Scotland, Hepatitis C beneficiaries can apply for an annual payment by filling in an application form and stating whether their life is severely or moderately affected by hepatitis c infection, or a whether hepatitis c infection does not have a noticeable day to day impact on life. The Scottish scheme provides guidance on what should count with in each category and does not require evidence to back up the category selected, however information must be provided showing examples the impact hepatitis C has on life and the majority of applications are not subject to any additional checks. Scottish beneficiaries are required to re-assess the impact of their Hepatitis C every three years so that payments can be amended if the impact has either reduced significantly or got significantly worse.

The following table shows Scotland's payment rates with the payment rates for Hepatitis C impact tiers highlighted in bold.

### Wales - Enhanced Hepatitis C Stage 1+ Scheme

Wales offer an enhanced payment, referred to as the Enhanced Hep C Stage 1+ Scheme payment, for those with existing Stage 1 hepatitis C who are suffering from mental health symptoms which they consider to be related to their being infected with hepatitis C and where the mental health symptoms that they are experiencing have an effect on their ability to carry out day to day activities. The enhanced payment is equivalent to the current rate of payment for those at Stage 2, hepatitis C infection and claimants self-assess if they believe they are entitled to this higher rate.

The following table shows the payment rates available in Wales with the Enhanced Hepatitis C rates highlighted in bold.
