- 11. After the meeting Su and I had just got back into my car when she took a phone call from James Hardy from EIBSS. Mr Hardy had called to tell Su that

he had not yet received her application and the resulting discussion between them lasted around 15 to 20 minutes.

12. During the conversation Mr Hardy told Su that it would be easier or more straight-forward if she refrained from talking to MPs, ministers and the press. Whilst I could only hear Su's side of the conversation properly, I understood the gist of what was being said because Su repeated a lot of what Mr Hardy was saying out loud. When he told her not to speak to MPs, ministers and the press, she looked shocked and a little annoyed but the conversation ran its course. Su explained to me what had been said to her in full after the phone call had finished. She did not appreciate him approaching her in that manner and what he had said to her.
