The Blood Products Laboratory (Elstree) currently supplies only England and Wales. Scotland has its own facility which also serves Northern Ireland. Information relating to Scotland and Northern Ireland is a matter for my right hon Friend the Secretary of State for Scotland and the Secretary of State for Northern Ireland. Where information is not held, or is not held in the form requested, this is indicated in the Notes.
