I had a think about this - I think we need to know more about the status of the witness report - was it prepared for a court of law or some other process, and the appendices - are they personal correspondence only in the sense that they are written by professor Bloom, or are they **about** Prof Bloom. In either case unlikely to be covered by LPP, as they are not advice from a legal adviser - just hapem to be found in a (legal?) context. If personal data about Prof Bloom, is he/she still alive, and is there any sensitivity about the data. If sensitive, section 40 may apply. If not, I doubt if it would be protected by any exemption.

Veronica,

Thank you for this. I will get back to you about any issues surrounding these papers attached to my first email shortly.

Could I ask your team to look at one more set of documents - we are going to release some documents around this issue that have recently come to light and we need to ensure that we publish any other relevant documents that were found with these and that are not exempt from release under FOIA.

The other set of documents that we are concerned about, in addition to those mentioned in my last email, are the appendices to an expert witness report written by Professor Bloom, a doctor very active in the Haemophilia community, for the 1989 HIV Haemophilia Litigation. The report itself is not within the 1970-1985 range of dates for the documents we are committed to release, however, there are many letters in the appendices that date from 1970 - 1985. This is Professor Bloom's personal correspondence to DH and to other organisations, such as the Haemophilia Society. Is this exempt for release under the FOI act? I would assume that, as with the documents below, section 42 would apply. There are about 200 pages of these appendices so I am hoping you will be able to give me a general answer to this one.

We have not had any response from Lord Archer about when he will release his report. However, we would like to release any necessary documents to the inquiry as soon as possible, and to that end, Liz Woodeson wants to send a submission up to Hugh Taylor by early next week at the latest, so a quick response to both the queries would be greatly appreciated.

I am away Friday and Monday, so please call William Connon on [GRO-C] if anything comes up on those days. Otherwise, please call if you need me to clarify anything.

Steve,

I just spoke to Veronica Fraser who asked me to email you. The blood policy team has found some documents dated from 1971 to 1985 in a folder marked Legal Profession

Privilege. These documents are legal advice about DH liability related to the issue of contamination of blood and blood products. As you may know, we have made a commitment to publish all relevant documents from 1970-1985 about this, and to provide copies to the Archer Inquiry. I assume that these documents would be exempt from publication as they are legal advice, but I would be grateful if you could advise on this. There is some urgency to this, as if we were to release these documents, we would like to do so before the Archer inquiry reports.

I attach a copy of the documents (19 pages).
