Dear Claire

I have recently received the below email from my constituent Mr Mike Dorricott. I have been in contact with Mr Dorricott for some time in regards to the issue of contaminated NHS blood.

Mr Dorricott is a haemophiliac sufferer who was treated Hep C contaminated blood in late 1982. He cleared this naturally by the middle of 1985. He was then re-infected in September 1985 following further treatment. He was then put onto 'Combination Treatment' which resulted in multiple adverse side effects. In 2000 Mr Dorricott received a new liver which, as expected was re-infected with Hep C. Unfortunately he also developed cancer of the liver which was diagnosed in 2007. He then received his second, and final, liver in 2008.

I would be grateful if you would investigate Mr Dorricott's concern and respond directly to me.
