AIDS

As a result of themeeting held on 3 June '83, HSIB circulated the questions listed in Dr Walford's minute of 14 June (copy attached) to suppliers and possible suppliers of coagulation factor concentrates. A copy of the questionaire was sent to ten companies, mine have replied five of which are suppliers in the UK. Attached is a summary of the replies from these firms. You may also wish to note the following points:-

- a. Merck, Sharpe & Dohme Ltd and Amersham International Ltd do not supply blood products in the UK.
- b. Hoechst Ltd have applied for product licences which are still being considered by CSM.
- c. Speywood Labs Ltd do not manufacture human coagulents.
- d. The following firms are suppliers of blood products in the UK:-

Alpha Therapeutic Ltd Armour Pharmaceuticals Ltd Travenol Laboratories Ltd Immuno Ltd Miles Laboratories Ltd

- e. Annual imports of FVIII by the above firms total about 42 50m units.
- f. With the exception of Immuno the firms state they do not or have ceased to collect in 'Epidemic' areas. All state that their collection centres are FDA licensed.
- g. The plasma in each case is pooled prior to processing. In the case of Immuno products, European plasma and USA plasma are pooled separately.
- h. The origin of all plasma is identifiable.
- i. Each has given the assurance that future sales will comply with FDA guidelines. However, Miles Labs state that FVIII manufactured from plasma collected since March '83 will not be available until August, and Immuno in September '83.

The tenth company, Cutter International Ltd, have not yet replied. The product previously sold in the UK by this company is now being marketed by Miles Labs Ltd who have applied for a licence on assuming responsibility for the product.
