# 2. Matters Arising from the Minutes

LW had written to Kate Soldan explaining that the data on age and the gender of positive donors would be difficult to obtain due to lack of resources. IR had not been able to do this yet, but hoped to find the data before the Cambridge/Brentwood merger on 16.12.96.

#### 3. Results of NBS East Anglia Lookback (See attached)

LW reported that a few patients were still in the pipeline for testing, but the numbers sampled on the flow chart was correct. A third positive patient had been identified since the last meeting, but he had received blood from a category three donor from whom six other recipients had tested negative. Interestingly, he had had a bout of clinical hepatitis following surgery, but prior to the implicated transfusion. LW was attempting to obtain further information and possible archive sample from Ipswich Hospital.

There was discussion on handling of the donors. It was agreed that although a number were probably false positive, there was no option at the present time but to remove them from the panel. Vaccination might be an option in the future, but was unlikely to provide new scientific evidence, and at the moment there were no resources for this. It would theoretically be possible to re-contact donors in the future should this become an option. Those with detectable but low levels of anti-HBs would be the first group with whom to begin.

It was agreed that donors who had gone abroad would not be followed up, but some success had been achieved with follow up of donors throughout the UK.

## 4. South Thames Update (See attached)

The study was going well, but it was estimated that a further six months would be needed for completion. This would require a further extension to UW's contract, and resources to pay additional nursing time. See next item.

#### 5. Finance

It was agreed that Abbott will pay for genomic testing directly to RST at the higher rate of £30 per sample. A price of £25 per sample was recorded in the minutes of 17.01.96, so any surplus could be used for sequencing the two HBsAg positive samples.
