His father, Angus, was also said to be under the care of the Royal Free Hospital for epistaxies.

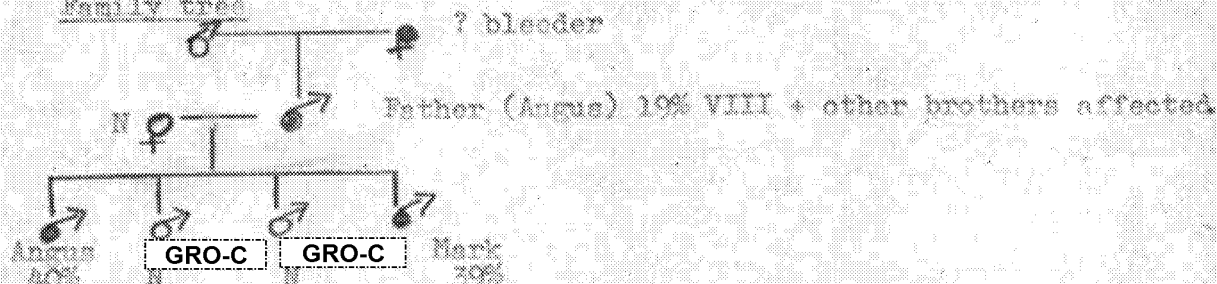

Bleeding episodes are confined to epistaxes. Angus is more severely affected than Mark. They respond to cryoprecipitate with piriton cover.
