Fitness to practise referral

I write further to my letter dated 5 August 2015 explaining that the Nursing and Midwifery Council (NMC) had received a referral regarding your fitness to practise. Following a review of the information we have received in this matter, I can confirm that the NMC will not be investigating the matter further at this time.

Upon receipt of the referral, the NMC contacted your employer, Royal Free London NHS Foundation Trust ("the Trust"), to obtain an employment reference and request identification.

The information received from the Trust appears to be guite positive and shows that there are no concerns regarding your fitness to practise. The Trust further stated that they have not been any previous complaints or concerns regarding your fitness to practise and that there has been no formal disciplinary actions against you.

This matter was also subject of a police investigation and, due to the nature of the allegations involved, we understand that it was referred to the Crown Prosecution Service. However, an email received from the police on 10 August 2015 confirms that the case has been completed and there will be no further actions taken.

In light of the above and all the information received regarding this matter, we have decided that it is not appropriate for the NMC to investigate this matter further, as there appears to be no concerns regarding your fitness to practise as a nurse.

As we have decided not to take any regulatory action at this time there is no requirement for you to disclose this matter to future employers and we will not disclose it to anyone making an enquiry about your registration. However, we may need to conduct

further investigations should any additional relevant information come to light. We will inform you immediately should this be necessary.

We appreciate that it is always difficult being the subject of a complaint and we thank you for your patience and cooperation with us.

This includes where one of our practice committees has made a decision on a case involving a nurse or midwife where there has been harm, or risk of harm posed to children or vulnerable adults. In the interest of public protection, we may also share information where appropriate, with other regulatory bodies and organisations.
