- 2. My father, Craig Christopher Fletcher (born on GRO-C 1971), was infected with the Human Immunodeficiency Virus (HIV) through contaminated blood products. He died having developed Acquired Immune Deficiency Syndrome (AIDS) and died at New Cross Hospital, Wolverhampton in GRO-C 1994, aged 22.
- 3. This witness statement has been prepared without the benefit of access to my father's medical records.
- 4. My brother, Nico Fletcher, has also provided a Witness Statement to the Inquiry (WITN4548001).

Section 2. How Affected

5.	My father was one of two sons. He and his brother, Nicholas, had
	Haemophilia A. They were treated with Factor VIII (FVIII) concentrate. I am
	uncertain as to the Haemophilia Centre responsible for my father's care.
	Given the GRO-C locality, it may have been the Birmingham
	Haemophilia Centre at the Queen Elizabeth Hospital. My paternal
	grandfather administered the FVIII concentrate to my father and my Uncle
	Nicholas at home.

- 6. My grandfather told me that a Social Worker knocked on his door and informed him that his children had HIV. In short, he received a knock at the door and was told that his children would die. My Uncle Nicholas was just 17 years old when he died.
- 7. I do not believe that my father and/or his parents were pre-warned of the risk of infection through FVIII concentrate. The death of two sons had a terrible effect on my grandfather. On one occasion, he even GRO-C He went quiet and would shut down when I spoke about my father, but I do know that he blamed himself for administering the FVIII concentrate to his two sons. He said 'I pumped that shit into my kids'.

8. I do not know whether or not my father was infected with anything other than HIV.

10. My mum and dad were young when they met and became parents. My
mother already had my older sister from a previous relationship. I was borr
on GRO-C 1991. My brother, Nico, was born on GRO-C 1992. Ou
parents married in December 1993 just before my father died in January
1994. I was just three years old.
11.My friends and cousins had fathers and had great relationships with both
parents. I spent my entire childhood wondering about my dad. My mother
never got over the loss of my father. She GRO-C

12. When we were young, our mother told us that it was cancer that had killed my father. Without me knowing why, we were ostracised by the people in our local community. The news that may father had died from AIDS spread through the grapevine. Out of ignorance my father was thought to have been gay or a drug addict. Because of the associated stigma, the children in our street were reluctant to play with us. We found out that my father had died from AIDS in our early teens.
13. My mother described my father as a very quiet, timid and loving man. He was
a good husband to her. She was widowed at the age of 23 with three young
children and never got over it. She GRO-C
GRO-C My mother never did a day's work. We suffered financially
and were dependent upon benefits.
14.I would like answers as to why this was allowed to happen to my father and our family.

15. We were never offered any counselling or support.
