I provide this statement in response to a request under Rule 9 of the Inquiry Rules 2006 dated 5<sup>th</sup> November 2018.

I, June Monaghan, will say as follows: -

### Section 1. Introduction

My name is June Monaghan. My address is known to the Inquiry. I
intend to speak about my husband Robert Monaghan and his infection
of hepatitis C. In particular, the nature of his illness, how the illness
affected him and me, the treatment he received and the impact it had on
both of us and our lives together.

#### Section 2. How Affected

2. Robert was involved in an incident in the 1980s when he injured his fingers when he was fitting some carpet which resulted in him having to attend hospital and receive a blood transfusion. He also was admitted to hospital years later for an operation to his wrist which resulted in a

transfusion. This was before I met him (I met Robert in the early 2000s) so I am unsure on the events around this. What I do know is that it left him needing a transfusion and this has caused him to contract hepatitis C.

- Years later Robert and I were tested for HIV and hepatitis C at Gartnavel Hospital. My results came back negative but Robert's results came back positive. We were stunned and devastated by these turn of events and it left us reeling.
- 4. We were given no information about hepatitis C, but we were left feeling as though it was a junkie's disease. Robert does not abuse drugs but this is what he has been accused of.

5. Robert has not contracted any other infections other than hepatitis C but he has now developed cirrhosis from this.

#### Section 4. Consent

- Robert and I have been treated and tested properly over the years for this, however the information has always been cagey and I do not believe the doctors have shared all the information they could have with us.

8. Robert's health has suffered over the years. He has always been very tired and unable to work for many years without a clear explanation as to why before he was diagnosed with hepatitis C. Being told that he had hepatitis C had a big mental and physical impact on him and on
