6.	After GRO-B's accident and from then on, he would regularly turn yellow. It was stranged he always had a slightly funny colour to him but I couldn't figure out what was wrong. He moved to Leeds and distanced himself from the family. Everytime we spoke or we saw him he looked unwell, he had purple marks on his body as well, all over his arms are legs. I was always worried about him when I did see him and confused, I couldn't understand what was wrong. Close to his death I saw him and his stomach was swollen and his legs kept giving way. It was quite shocking to witness.
7.	He always seemed to have chronic fatigue and developed diabetes type 2 as an adult Again he never spoke about how this affected him. He kept the family very much on the fringes and we didn't understand why.
8.	The only thing that GRO-B did tell me was that he was ill because he was drinking a lot. He knew what was actually going on, that he had hepatitis C, but he actively hid it from me and the family. We all believed that he had cancer.
9.	GRO-B passed away on the 7th January 2021. I went to Leeds GRO-B  GRO-B had hepatitis C. GRO-B he hadn't wanted us to know because he was scared at what our reaction would have been. His fear was that we would think that he could infect us but that is simply not the case. We are a very close

	sisters, 2 have passed away now. All of his siblings would have supported him. One

	him over the years and it felt as if he was distancing himself from us.
