This gentleman was recently admitted with mild confusion and a flap with grade 1 encephalopathy. I had recently received a letter from Dr Patch suggesting that prior to renal transplantation, it might be useful to perform a TIPPS procedure to provide hepatic bypass and decompress his portal hypertension reducing the portal pressure and thus reducing his hypersplenism and tendency to bleeding.

Unfortunately, on two occasions in the last two months, he has presented with a clinical hepatic encephalopathy with confusion, dyspraxia and a flap. On this occasion, his ammonia level was elevated at 193.

We plan to give him Neomycin, Octreotide and Midodrine to attempt to mitigate episodic bleeding and hypotension on dialysis, which may contribute to this syndrome. I am going to ask James O-Birne, the consultant hepatologist who looked after Mr Spellman in the past to review him in Dr Patch's absence.

In light of recent development, the TIPPS procedure may not be the best way forward.
