23 April 84 US Statement announcing discovery of HTLV3
testing. (HIV)

23 April 84 Background Note on AIDS virus.

14 June 84 Article on the development of US kits to test for
HIV - "Nature" Vol 309.

25 June 84 Suggested meeting to discuss possibility of
obtaining US Kits for use in the UK.

28 June 84 Letter from Dr Gunson to Dr Smithies:-
NBTS Director, Chairman of MRC Committee on
AIDS, Consultant Virologist at Middlesex
Hospital, Consultant Immunologist at Bristol BTC
and Director of NW Thames RBTC meet to discuss
possibility of obtaining US test kits. Also
agreed that the test should be regarded as a
research project and that it should not become a
routine screening test on blood donations without
proper appraisal. A three stage plan was
agreed to effect this.

June 84 US select 5 companies to produce the diagnostic
blood test for HIV antibodies.

end of June 84 51 cases of AIDS identified in the UK (28 of
these have died)

- 0 11 July 84 RTC Directors meet and agree:-
a) urgent priority be given to setting up a group of experts to advise HAS and
b) the need to seek legal guidance on the implications of screening tests for HIV and
c) that the NBTS could forecast a screening test is likely to be available within the next two months or so for trial at the Edgware Centre and then at Bristol and Manchester.
- 1 27 July 84 DHSS group of experts set up to provide guidance to the Health Authorities on how to handle problems arising from the consequence of screening for HIV. Ministers informed.
- 1 31 July 84 DHSS officials agree that ministers should be kept informed of all plans and proposals re HIV screening and that extra funding for the tests be sought from Central Funds.
- 2 10 August 84 DHSS seek permission from US to use their antigen in order to enable more widespread testing in the UK.
- 3 31 August 84 Briefing for Lord Glenarthur
- 4 31 August 84 Guardian article
- 5 1 September 84 Lancet article.
- 6 19 October 84 New Scientist Article.
- 7 19 October 84 Laboratory at Middlesex Hospital completed and ready to start testing of kits.
Forecast that by the beginning of November sufficient reagent will be available to begin testing blood donations at the North London Transfusion Centres.
- 8 25 October 84 CMO agrees that HIV testing is carried out on the basis that negativity is a pre-requisite for donation of blood or plasma.
- 9 22 November 84 MS(H) declines funding for AIDS test - ITV interview 22 November.
- 10 23 November 84 PQ reply on availability of screening tests.
- 11 28 November 84 It is anticipated that the UK would be able to meet demands Blood Products by the end of '86 providing enough plasma could be collected and the new BP lab was completed.

PQ written answer about

- a) Government financial support to be given support to be given through MRC.
- b) Revision of leaflet - "AIDS and how it concerns blood donors."
- c) Strengthened efforts to dissuade people from donating blood if they are at high risk of transmitting AIDS virus.
- d) RTCs to be asked to ensure leaflet is given to every single donor within the NBTS.

- 5 11 January 85 Submission to Ministers asking for agreement in principle to introduce the HIV blood test.
- 4 29 January 85 EAGA (Expert advisory group on AIDS) 1st Meeting - Screening Test Sub-Committee formed.
- January 85 HC(85)3 revised leaflet on "AIDS - important new advice for blood donors.
- 0 13 February 85 Initial evaluation of HIV tests conclude that a comparative evaluation must be carried out among representative groups of UK donors before the introduction of any present commercially available screening tests.
- 7 15 February 85 EAGA Screening Test Sub Group meet to discuss the update on availability and the timetable on the introduction of the screening tests.
- 3 18 February 85 RTC Directors meet. Proposed that VRL (Viral Reference Laboratory) at CPHL (Central Public Health Laboratories) at Colindale conduct an initial evaluation of the diagnostic kits. Field trials to follow on kits which pass the first evaluation (NBTS to do).
- 1 1 March 85 EAGA Screening Test Sub Group meet to discuss details of how the testing of the kits will take place.
- 18 March 85 Discussion in the House of Lords on HIV screening. (Oral PQ 3465/84/85)

31 28 March 85 EAGA Screening Test Sub Group meet to further discuss the progress of the testing of the kits and the repercussions of HIV screening once implemented.

2 April 85 Report on the introduction of a HIV test.

16 April 85 EAGA Screening Test Subgroup meet.

16 April 85 PQ oral answer on availability of tests.

5 10 June 85 EAGA Screening Test Subgroup meet to discuss:
a) Progress on evaluation of kits
b) RTC Directors proposals for informing donors
c) Draft paper on how to inform doctors about the introduction of screening tests.
d) Follow-up of earlier positive donations.

6 27 June 85 Press Release to announce the introduction within the next few months of the HIV screening test.

11 July 85 Report from the Working Party of RTC Directors meeting on 10 June 1985.

8 30 July 85 Letter to RGMS asking them to provide testing facilities outside the BTS.

9 30 July 85 CMO to SofS on AIDS and the treatment of haemophiliacs.

0 1 August 85 Press release on the above.

1 1 August 85 Letter to RGMS, DGMS, GMS, PG Teaching Hospitals, RSCOs,RSOs, RMOs DMOs and RTC Directors informing them of the outcome of the tests on kits.

2 1 August 85 Letter to RTC Directors with action to be taken to introduce HIV testing from 14 November 1985
