Dear Su Gorman,

Thank you again for your time last Friday 1st February 2019.

I tried calling you earlier today to discuss these points but unfortunately your phone was off, so please can you kindly consider the points below and advise us of your decision.

Firstly I can confirm that we've received your completed 'Contact preferences and change of details form' and supporting evidence, I also confirm that the form has been completed correctly and the supporting evidence appropriate. England Infected Blood Support Scheme (EIBSS) is therefore able to make the £4,500 quarterly payment, upon receipt of instruction from you.

Secondly, I agreed on the call with you last Friday to have the evidence you supplied with this application reviewed, to understand if it would be suitable to support your application for a lump sum payment for bereaved spouses/partners. I can confirm that an EIBSS Medical Assessor has verified that this is suitable evidence to support your application.

We would therefore welcome a decision from you regarding what you would like to do next, as you have a couple of options available.

1) We could pay the £4,500 quarterly payment to you as soon as possible, via faster payment tomorrow, if you confirm that decision to us by 10am.

If you choose to receive this payment you would still be able to complete the application for a lump sum payment for bereaved spouses/partners. Upon receipt of the completed form, supported by the verified evidence we now have on file and the additional evidence detailed below, we could make a payment of £5,500. Combined this would equal the £10,000 lump sum payment for bereaved spouses/partners.

2) Now I have confirmed that we have verified medical evidence to support an 'Application form for lump sum payment for bereaved spouses/partners' you may choose to hold-off on receiving the £4,500 quarterly payment and await the £10,000 payment, following receipt of your completed application.

Both the EIBSS team and I stand ready to assist you and act upon your instructions but need you to notify us of your choice from the options listed above.

Both options require you to complete application form 'Application form for lump sum payment for bereaved spouses/partners', which has been provided to you previously but we could send another copy, if you require.

The evidence we would need to support this application is as follows:

- Proof of ID (for example, a copy of your passport, driving licence or birth certificate)
- Proof of your current address (for example, a copy of your bank statement or utility bill)
- Evidence to show that you were co-habiting at the time of your spouse/partner's death (for example, a joint bank statement or joint council tax bill), or if not available a completed Referee Form (Appendix 1 of the application form).
