- 10. My sister and I attended hospital appointments with our mom, to which I went to the Queen Elizabeth Hospital in May 2015, when mom was told there was nothing more they could do for her. When she came out of her appointment, she was a broken lady who lent against the wall and collapsed to the floor. She wanted to try and carry on until Christmas and set herself a goal, but unfortunately this dreadful, cruel disease which should have never happened took her away from us in September 2015.
