

ETHICAL GUIDANCE CHRONOLOGY

1. The Ethical Guidance Chronology (the '**Chronology**') is a timeline of publications, cases, events, legislation, or advice issued to, or affecting, the medical profession and which touch on matters relating to medical ethics as relevant to the Inquiry's Terms of Reference. It is intended to be used as a reference document, providing background information and context to assist participation in the Inquiry. It forms a part of the presentation on Ethical and Clinical Guidance for Clinicians and Other Healthcare Practitioners.

- 5. The content of the Chronology is not to be taken as a finding or statement of fact by the Inquiry. Nothing in the selection of, or description of, any entry should be read as indicating that the Inquiry has reached any conclusions as to the underlying facts and matters into which it is inquiring. Nor is it to be assumed that each selection is of equal relevance or weight to any other, or

that the selections overall imply that particular weight is given to any one point of view.

6. The Inquiry is not inviting Core Participants either to agree or to disagree with the contents of this Chronology.
