### Section 2: Response to criticism of Luke O'Shea Phillips

In paragraphs 15 and 16 of his statement, Mr O'Shea Phillips claims that he and his mother were informed of his hepatitis C (HCV) infection by way of a letter sent by you on 6 January 1997. This is despite the fact that he first tested positive for HCV in 1993 and that his medical records referenced his infected status several times before the date of your letter. Please comment on this.

- 5. I first met Luke in October 1993 when he attended the Hammersmith Hospital as an emergency because he had a bleed into one of his muscles. He had previously been under the care of University College Hospital. The previous test for hepatitis C (WTN1696007) was not available to me at that time.
- 6. Following his treatment at the Hammersmith Hospital we performed a test for hepatitis C antibodies which was positive and this was subsequently documented in his notes. I agree that it was in 1997 that I wrote to Ms O'Shea about this infection. As stated in my response to Ms O'Shea's statement, when writing the letter, I believed that Ms O'Shea was already aware of the diagnosis and it was not my intention to give her such important new information in this way. I would like to apologise again for this misunderstanding and the consequent delay in providing this information.
- 7. My intention in writing the letter was to arrange an opportunity to discuss the possibility of treatment of hepatitis C with Luke and his mother.
