Section 2: Responses to criticism of John McDougall

4. I am asked to comment on Mr McDougall's comments that I knew why the West Glasgow Ambulatory Care Hospital used American blood and/or blood products and that I was responsible for sourcing those products.

I am grateful to the Inquiry for affording me the opportunity of commenting. I have read the statement of Mr McDougall and would like to offer my sincere condolences to his

family. The emergence of HIV and the devastation it caused to our patients, is a tragedy.

I should advise that I have not had access to Euan McDougall's medical records for the purpose of preparing this response. I understand that they have been destroyed. I do not, however, consider that I require access to allow me to respond to the criticisms made.

I wish to assist the Inquiry with their work as much as I am able to do so. I am, however, now 92 years old and am having difficulty in recalling events which took place 36 years ago.

I am unaware of the existence of the West Glasgow Ambulatory Care Hospital I am advised that this is now based at the former Yorkhill Hospital. The Children's Hospital at Yorkhill I understand has now closed and its work has transferred to the Royal Children's Hospital at the Queen Elizabeth Hospital in Glasgow.

For the reasons I have narrated, the best evidence I can offer to the Inquiry as to my choice of blood products is set out in the evidence I gave to the Penrose Inquiry by way of written statement.
