INFECTED BLOOD INQUIRY

SECOND WRITTEN STATEMENT OF LIAM MCIVOR

I provide this statement in response to a request under Rule 9 of the Inquiry Rules 2006 dated 12 August 2020.

I, Liam McIvor, will say as follows: -

1. At 2(b) of your response, you refer to the Service Level Agreement between Regional Business Services Organisation (BSO) and the Department of Health Northern Ireland (DHNI), which is attached at WITN4507011. The Agreement states that BSO makes decisions about eligibility before seeking additional funding from DHNI, who will then "determine" how much money will be paid out under the Scheme. Does DHNI accept BSO decisions about eligibility at face value, or does it perform a further review function in "determining" how much funding the Scheme will receive?

The Northern Ireland Department of Health accept BSO decisions on eligibility to the scheme. The DHNI use the SLA statistics to determine how much funding the BSO can draw down to meet the requirements of the scheme.

3. In respect of your response at 2(d), why has the Scheme not undertaken any reviews or consultation regarding its policies or level of payments?

4. Also in respect of your response at 2(d), did the Scheme receive the records of transitioning beneficiaries from the Alliance House Organisations? If not, why not

The Scheme did not receive the full records of transitioning beneficiaries other than what was contained in the spreadsheet information forwarded from the Alliance House Organisations to the BSO. Please see WITN4507021 which details the spreadsheet headings from the Alliance House Organisations. The full paper records of transferring beneficiaries were not forwarded to the BSO due to Alliance House instructing that this information could not be released.

5. Your response at 4(a) states that 3 new beneficiaries have been accepted into the Scheme since 2017, but your response at 5(d) states that 11 applications have been granted and 7 have been refused. How are these number reconciled?

Granted Applications Response

Please refer to WITN4507006 schedule of applications on the first rule 9 response. Cases 4-7 relate to two new registered scheme beneficiaries (non- infected widows) who forwarded applications in relation to their deceased husbands and their bereavement payment entitlement. The other applications granted in relation to cases 1-3 & 8-11 are original beneficiaries from the Alliance House Organisations.

The third new beneficiary previously received a lump sum payment in respect to their Hepatitis C stage 1 infection in 2005 and no further payments from the Alliance House Organisations. The beneficiary contacted the Northern Ireland Scheme in August 2018 and monthly payments were initiated and backdated subject to verification checks and no application was required except for a completed information form and therefore was not included in the statistics under 5(d)

Declined Applications Response

In relation to applications refused/declined cases 12-14 and 16-18 relate to original beneficiaries from the Alliance House Organisations and case 15 refers to one of the new beneficiary widows who forwarded an S2 application in respect of their late husband which was declined.

6. Your response at 4c states that 85 beneficiaries receive ongoing payments – of these, how many receive annual payment versus weekly or monthly payments?

Of the 85 beneficiaries receiving on going payments none receive weekly payments but all beneficiaries receive an annual winter fuel allowance.

On-going payments are either on a monthly or quarterly basis.

55 are paid on a monthly basis and 30 on a quarterly basis.

Four of the quarterly paid beneficiaries also receive a monthly Income-top up payment.

The decision to be paid monthly or quarterly rests with the beneficiaries

7. In respect of your response at 4(d), why have no steps been taken to identify additional beneficiaries?

8. In your response at 5(a), you state that BSO is the decision maker with respect to eligibility for the scheme. Please set out who in BSO makes these decisions and on what basis?

The decisions makers within the BSO are as follows:

Mrs Wendy Thompson Director of Finance Mr Simon McGrattan Assistant Director of Finance Mr Colin Murray Scheme Manager.

The basis for the decisions comes from the DoH Service Level Agreement along with guidance/clarification from the Northern Ireland Department of Health civil servants. The civil servants are as follows

- 9. What policy documents are referred to in your response at 5c? Does BSO or DHNI use policy documents other than the Service Level Agreement in the decision-making process?
 - A. For example, the Service Level Agreement states that DHNI is responsible for granting applications for discretionary payments but does not detail the criteria used?

B. For example, your response at 2(b) states that BSO "interprets policies in conjunction with DHNI to create the procedures to administer the scheme" Does this mean there are separate BSO policy documents and procedures?

10. Your response at 5(d) refers to the fact that 7 applications for payments under the Scheme have been refused. 4 of these applications were refused after a second medical opinion was received. Is it common practice for the Scheme to obtain secondary medical opinions for applications? If so, is this done pursuant to a particular policy or procedure set by either BSO or DHNI?

The BSO will ask for a second medical opinion on applications if the medical professional diagnosis is of a complex technical nature and requires another clinician(s) to interpret the diagnosis. This is a procedure set by BSO due to the lack of medical expertise within the Finance Directorate.

11. Your response at 6(a) purports to attach a spreadsheet of payments made to beneficiaries at WITN4507014 but the attached spreadsheet list levels of payments rather than a list of payment made? If so, please provide a copy of this document.

12. In respect of your response at 6(d), there is a significant increase in quarterly payments between the October – December 2017 and the January – March 2018 (nearly £70,000) Does this reflect the introduction of the additional 3 beneficiaries into the Scheme?

The reason for the increase in expenditure from October – December 2017 to January – March 2018 is due to no monthly payments being made to beneficiaries by the BSO in October 2017 as the Alliance House Organisations processed the October 2017 payment. Furthermore beneficiaries who receive payments on a quarterly basis received their first payment from the BSO in January 2018 rather than October 2018 as this payment was processed by the Alliance House Organisations.

13. There is very little public information about the policies of and payments made by the Scheme. In particular, there does not appear to be a public document that sets out the Scheme's payment rates. Why is this the case?

Information is contained on the Northern Ireland Direct website and the BSO website. Any information published regarding the Scheme's payment rates must first be agreed with the Northern Ireland Department of Health. Please refer this question to the Northern Ireland Department of Health.
