Section 2: Response to criticism of W2287

 As above, I was the Scottish Government's Minister for Health and Community Care between October 2004 and May 2007. I am obviously disappointed at the characterisation of my position during this period on this very sensitive matter, the whole issue has been devastating for individuals and their loved ones.

- 6. In the opening to my written evidence to the Health Committee on this issue, I stated "I have every sympathy with those affected with Hepatitis C through NHS treatment. However, I remain to be convinced of the usefulness of a public inquiry into this matter. I am not convinced that there are any lessons to be learnt that have not already been learnt."
- 7. I also stated that "officials within the Health Department continue to respond to requests under Freedom of Information and I have requested that they be as open and transparent as possible. I have also commissioned a literature review of all the files held with a view to publishing relevant documents. This should provide a full picture from the written record of what happened."
- 8. I stated that I considered an inquiry was unlikely to uncover any new relevant evidence or information and would bring little benefit to the patients involved and I would refer you to the submission made by me on behalf of the Scottish Government to the Health Committee.
- 9. On the basis of the evidence and information before me, I did not believe that a public inquiry in Scotland would either uncover any new evidence or information that is relevant to the causes of the infection of NHS patients through blood and blood products, or lead to significant lessons for the future.
- 10. The purpose of the Skipton Fund scheme was to provide help to individuals with the extra costs that can arise from living with hepatitis C. I also commented at the time there was a balance to be struck between funding ex gratia payments to those affected and funding other demands on the health budget. As such, I did not consider there was a strong enough case for extending payments to dependants of those who died before the announcement of the payment scheme, that is, 29 August 2003.
