 The criticisms the Board has been asked to address are:
 - "2.1. At paragraph 6 of witness W2186's statement, the witness states that in September 1978 when she telephoned Glasgow Royal Infirmary to inform them her husband had been ill with hepatitis following a hernia operation, she was told. "Nobody else has it!".
 - 2.2. At paragraph 13 of witness W2186's statement, the witness states that her husband was tested for HCV in 1994 without being given any information or asked for consent.
 - 2.3. At paragraph 14 of witness W2186's statement, the witness states that at a consultation at the haematology department she and her husband were told, "We have infected all 3,000 of our patients with Hepatitis C". When she asked what to do next they were told, "You'll just have to learn to live with it!". Witness W2186 states the way in which she and her husband were informed of the diagnosis was very blunt with no consideration of the impact it would have.
 - 2.4. At paragraph 15 of witness W2186's statement, the witness states that "having realised the apathy and careless attitude of the Royal Infirmary," she requested her husband's treatment be transferred to a different hospital..'

The Board identified Professor Gordon Lowe as the most appropriate person to respond to the criticisms made. Professor Lowe is now retired but was Haemophilia Centre Director at Glasgow Royal Infirmary. He was one of the patient's treating clinicians and is the clinician towards whom the criticisms are directed. His response is attached (exhibit no WITN7116005).
